Announcement of the 2001 Prize

The Bernese Prize for Environmental Research

The Bernese Prize for Environmental Research has been created to support disciplinary and interdisciplinary research in the field of ecology and the environment at the University of Berne, Switzerland.

The Prize is funded by the Handels- und Industrieverein des Kantons Bern and the Kantonalbernischer Gewerbeverband - the two major trade and industrial associations of the Canton of Berne.

The Prize is intended to honour researchers for excellent scientific papers making a socially relevant contribution to the better understanding of environmental issues and/or the solution of related problems. Applications are accepted from all disciplines and areas of science.

It is intended primarily for young researchers.

Prize Sum

For 2001 the Prize is accompanied by a sum of 20,000 Swiss francs, which may be bestowed upon one or two papers.

Application

Research Papers must be nominated for the Prize by a scientist (with a doctoral degree), who isn't one of the authors of the work.

The nomination must be accompanied by the following documents:

- 3 copies of the nominated paper
- a scientific review of this paper by the nominating scientist or another third person as justification for the nomination

• curriculum vitae of the authors of the nominated paper, including bibliographies of published papers.

- The Prize may be given to one or several individuals. At least one of the contributors to the winning research paper must be a past or present researcher in the relevant field at the University of Berne. Contributions resulting from a cooperation between the University of Berne and other research institutions are especially welcome.
- As a rule the submitted paper should not yet have been published although it may be submitted or accepted for publication or future publication may be planned. The paper may be written in one of the official Swiss languages (German, French, Italian) or in English.
- The Committee may make summaries and a list of all submitted papers available to a broader public.

Timeframe

- Submission of applications: Any nominations for 2001, including all the required documents listed above, must be submitted by 28 February 2001 (postmark), addressed to: Interdisciplinary Centre for General Ecology (IKAÖ), Secretariat "Bernese Prize for Environmental Research", Falkenplatz 16, CH-3012 Berne, Switzerland.
- **Award ceremony:** The Prize will be awarded on Dies Academicus of the University of Berne, in December, 2001.
- **Public lecture:** In the course of the Winter Term 2001/2002, a public lecture by the award winner(s) will be held on the subject of the winning research paper.

Jurisdiction and Procedures

The Committee for the Bernese Prize for Environmental Research is responsible for any matters concerning this Prize, especially for the modalities regarding submission and review of papers, and the assessment of submitted applications. The Committee is at liberty to refer to external experts for reviews and assessments.

The decision of the Committee is final and may not be challenged.

Noone has any legal right to receive the Prize.
